Social security cards for everyone in the family: <b>no exceptions</b>
Photo ID for the Taxpayer and Spouse. A current Ohio Driver's License is preferred but employer ID cards with a photo, military ID, state ID card, and passport are also acceptable.
All of your W-2 forms from <b>all</b> of the jobs you worked from the beginning of 2024 through the end of the year.
Some taxpayers <i>may</i> have received Form 1099-K for tax year 2024 – it is important to bring these forms to the tax appointment if you received them.
Unemployment received in 2024 (1099-G). You can log into your online account and print your statement – please print your statement <b>PRIOR</b> to your appointment.
Social Security statements (1099-SSA).
All 1099-NEC (non-employee compensation) income forms if self-employed, and any other source of cash income.
If self-employed, have your business expenses documented, totaled, and available at your appointment.
If you have a health savings account (HSA), you must have you 1099-SA form if you took money out of the account last year.
If you have insurance through the Marketplace (ACA/ Obamacare), you must bring your 1095-A form.
Bring documentation related to your out-of-pocket health expenses. This includes your year-end pharmacy statement, co-pays for medical expenses, dental expenses, eye expenses hearing aids, and medical health insurance (including dental and eye) and long term care (LTC) premiums.
If you have children under the age of 13 and paid for childcare expenses while you worked or looked for work, bring your childcare provider receipt. It <b>must</b> contain the SSN or EIN of the person or organization caring for your child(ren), the provider's name and address, and the amount you paid for such care itemized for each child.
If you have a brokerage account, you must wait for your 1099-B forms. These forms often do not arrive before March so please do not schedule your tax preparation appointment before March 15, 2025.
If a member of your household attended college/university and received a Form 1098-T with tuition and scholarship information you must provide a school account statement for the year showing all college charges and payments.
Your bank's routing number and account number if you want your refund to be direct-deposited. Your debit card or payroll card does not have the information needed for direct-deposit so you may need to call your bank to get the required information in advance of your appointment.
Please bring your 2023 tax return. If you did not file a tax return for 2023 and need to do so, bring <b>ALL</b> of your 2023 tax documents as noted above in order to file a 2023 tax return.
Bring any letters received from the IRS, the state of Ohio, or the School District received in 2024.
Hardcopy/paper forms are required for tax preparation.
